COMMENT: I have read that Metro is putting anti-Israeli adds on their busses. While I agree that the Israeli persecution of the Palestinian people MUST stop (it is evil and I agree with stated agenda of the adds), Metro busses are not the forum for this dialog. What's next after this? Adds showing showing bombed Israeli school busses with dead Israeli children as the ripostes escalate? Adds showing waterboarding, Abu Graib and Guantanamo scenes condemning American war crimes? How about direct hate adds?

When I get on a bus, I just want to go safely from point A to point B. When I express political viewpoints (and I do) I go to rallies, write my congressional representatives, and attend lectures. I don't wish to silence anybody, I just want to get around Seattle. Stopping the adds would not stop rallies, donations, lectures and lobbying. If Metro sticks to non-political adds, nobody is silenced. Adds without controversy simply make bus rides safer for riders.

As a legally blind Seattle resident, I need to ride the bus to get anywhere I cannot walk. If you think all people riding Metro busses are riding sober or riding with all their mental and emotional facilities intact, please be advised this is not so. Along with the more benign behavior of people talking loudly to themselves on a large range of topics, I have had my life threatened by the not so benign mentally challenged, been coughed and vomitted on by a woman with either tuberculosis or lung cancer in a crowded 253 bus for a half hour, been grabbed and loudly prayed over by a man who believed he could heal my eyes, and been pushed down by riders who seem to have lost their capacity to say "Excuse me please, I need to get by." when they see a blind woman. Being knocked to a muddy wet bus floor is not a good Metro riding experience, particularly when you cannot see what's around you so you can get up safely.

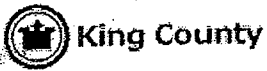

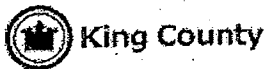

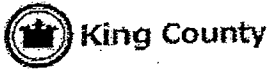
