On 02/07/11 I was working uniformed patrol duty in a fully marked patrol car as Unit 2K33 with Ofc. R. Bonesteel. At around 1607 hrs we were dispatched to investigate an assault that occurred at 5-3 Ave.

We arrived and located the victim. We noticed that the victim's right eye was swollen shut and he had red marks on his face and ears. The victim explained that the suspect that assaulted him also took five dollars without permission during the assault.

We notified radio that the incident would now be a robbery and had the suspect description broadcasted to the Metro bus drivers and other Officers. We requested SFD respond to treat the victim for his apparent injury.

SFD units responded and treated the victim at the scene.

Officers checked the area for the described suspect and was unable to locate the described person.

The victim was identified as [REDACTED]. The victim explained that while standing outside of the entrance to the premise an unknown B/M approached him and told him that he owed him ten dollars. The victim did not know who the B/M was, said that he didn't have any money, and began to walk away from him. The B/M then grabbed onto the victim's shirt and began to pull him closer to him demanding for the money, and threatening him that if he didn't pay he would hurt him. The victim was able to pull free and began to run up the stairs leading to the [REDACTED]. The B/M was able to catch the victim in the stairwell and shove him down onto the ground. The suspect then began to punch the victim in the face with a closed fist several times. The suspect then reached into the victim's front pocket on his shirt and took a five dollar bill and ran off, leaving SB on 3 Ave.

The suspect was described as a B/M in his 30's, approx 5'06, 150 lbs and wearing a white hooded sweatshirt with the hood up, a black BB cap, a dark blue jersey with the number 3, and dark jeans and tennis shoes.

We took photographs of the victim's injuries and got a victim statement. The victim agreed that the documented statement was true and accurate. We provided a business card with our names and case number and gave it to the victim and the [REDACTED] staff.

The [REDACTED] staff was able to retrieve video footage of the suspect. Staff was unable to provide a copy at this time but would get a copy and notify SPD when it is ready to pick up.
