That Lauren Givens is a Detective with the Seattle Police Department and has reviewed the investigation conducted in Seattle Police Department Case Number 2011-324235;

There is probable cause to believe that Jesse K. Drugge committed the crime(s) of Child Molestation and Indecent Exposure within the City of Seattle, County of King, State of Washington.

This belief is predicated on the following facts and circumstances: .

The suspect in this case is Jesse Kaein Drugge. He has several aliases; Jess K. Drugger, Jesse Kaine, Jesse K. Trulson, Jesse K. TrulsonDrugge. His birthday is 10.14.1982.

According to the database Washington Criminal Information Center (WACIC) DRUGGE was convicted of Indecent Exposure on 12.08.2005.

The victims in this case are JH (birthday 02.18.1998) and IS (birthday 02.10.1998).

On 10.2.2011, at about 4:30 pm, JH and IS walked to Pinehurst Playground located at 12029 14 AV NE Seattle, WA 98125. They were at the park for about 15 minutes, and JH noticed a male at the "T" in the path, walking back and forth, acting suspiciously. This male was later identified as DRUGGE, JESSE K. JH and IS got onto the swings. It started raining and everyone left the park except JH, IS, and DRUGGE. IS got off the swing and began to gather her belongings. JH was still swinging.

DRUGGE walked toward JH and IS with his penis out of his pants. DRUGGE was touching his penis with his hands. DRUGGE asked JH and IS if they needed any help. He then told JH and IS that he was not going to touch them. DRUGGE continued to close the distance. DRUGGE stood less than a foot away from JH. JH was afraid that if she got off of the swing, DRUGGE was going to attack her, so she kept swinging.

DRUGGE then ejaculated, striking JH's shirt with his semen. After DRUGGE ejaculated, he ran out of the park.

IS also saw DRUGGE expose his penis. IS said that DRUGGE walked closer to them and then "squirted stuff" on JH. IS stated that the "stuff" came from DRUGGE's penis.

At the time the incident was reported, the suspect was not identified. JH and IS provided the description of a white male in his 20s. The man was described as having a pointed nose and a pointed chin. He was described as tall and thin, and that his skin was pale, flaky, and dry. He was described as having a goatee and light beard, black in color.

JH and IS said the man wore a black hooded sweatshirt with the hood pulled up. There was some type of white logo on the back.

JH and IS met with the police department's sketch artist, who drew a composite sketch of the suspect based on their description. The suspect's sketch was published in the media, requesting the public's assistance.

After seeing the sketch in the media, a resident who lives near Pinehurst Playground, EM (birthday 12.05.1953), contacted the Seattle Police Department. EM stated that on 10.2.2011, around 4:45 pm – 5:00 pm, he noticed a man park his vehicle on NE 120 ST. EM did not recognize the man or the car. The male parked, pulled his hood on immediately, and then walked quickly into the Pinehurst Park. EM described the man as a white male, 20-30-years-old, dark brown hair, well trimmed beard/goatee, slim build, and about 5'10. EM provided the license plate of WA.349XDM.

I checked WA.349XDM in several law enforcement computer databases. Washington Department of Licensing showed that the vehicle was a gold 2000 Kia Sephia 4 DR. It showed the registered owner to be a female who lived in Kenmore, WA.

A law enforcement database showed that a male, JESSE K. DRUGGE 10.14.1982, had received an infraction while driving WA.349XDM in Kirkland, WA in 2010.

I then searched the name JESSE K. DRUGGE in several law enforcement databases.

According to Washington Criminal Information Center (WACIC) DRUGGE had been convicted of Indecent Exposure on 12.08.2005.

A law enforcement database showed DRUGGE as currently residing with the female registered owner of WA.349XDM in Kenmore, WA.

Washington DOL emailed me a photo of DRUGGE. The photo appeared strikingly similar to the sketch that JH and IS created with the police sketch artist. The physicals listed for DRUGGE (height: 5'11, weight: 150) also matched the descriptions.

I created a photo montage containing DRUGGE's photo and showed it to JH on 10.14.2011. JH selected the photo of DRUGGE as being the male who exposed his penis to her and who ejaculated on her.

On 10.14.2011 I showed the same photo montage to IS. IS selected the photo of DRUGGE as being the male who exposed his penis to her.

IS and JH were presented the photo montage separately, and at difference locations.

Several additional indecent exposure incidents came to my attention at the same time as I was investigating this case. The incidents had extremely similar suspect descriptions and similar modi operandi. Jesse K. Drugge was identified by victims and witnesses as the perpetrator in the following cases:

SPD 2011-326391: This incident occurred on 09.29.2011 at 1440 HRS at NW 90 ST and Holman RD NW Seattle, WA 98177.

The victims in this case are AN (birthday 02.14.2000) and MR (10.19.1999). AN and MR were sitting at the bus stop at NW 90 ST and Holman RD NW. As they were sitting in the grass and talking, MR and AN noticed a male walking around. The male then walked toward them and exposed his penis to them. The male then ran off W/B from the bus stop.

MR and AN described the male as a white male wearing a black hooded sweatshirt, with the hood up. MR stated the sweatshirt had a white design on the back. He was described as tall, thin, with a thin face, and cheek bones exposed. He was said to have a pointy chin with a goatee. MR and AN said that the male wore a black sweatshirt with the hood up.

On 10.17.2011, I showed the photo montage (created for 2011-324235) to MR and AN, containing DRUGGE. AN was not able to pick a photo and said that she did not get a good enough look at the male's face. MR picked Number 4 of the six photos featured in the montage. MR selected the photo of Jesse K. Drugge as being the suspect who exposed his penis to her.

SPD 2011-320914: This incident occurred 09.29.2011 at 1622 HRS at Whale Tail Park, 5851 SW Lander ST Seattle, WA 98126.

The victim in this incident is KW (birthday 05.27.2000). KW was at Whale Tail Park with his friend, MS (also a juvenile). As they walked home, KW noticed that a male followed him home. When they went inside, the male walked back and forth in front of KW's house. When the male was gone, KW and MS walked back to the park. They saw the male again. Now the male had his penis exposed and might have been masturbating.

At the time of the report, KW provided the description of white male, 30-49-years-old, with a mustache/partial beard. KW said that the suspect had a black hood sweatshirt on.

On 10.14.2011 Det. Stangeland showed KW a photo montage containing DRUGGE. KW selected Number 4 of the six photos featured in the montage. KW selected the photo of Jesse K. Drugge as being the male who exposed his penis to him.

SPD 2011-324809: This incident occurred on 09.29.2011 at about 1730 HRS at 23 AV E and E Aloha ST Seattle, WA 98112. This incident occurred near Holy Names Academy.

The victims in this case are KN (birthday 04.16.1995), KM (birthday 03.28.1996), and MK (birthday 05.13.1996). KN and KM were sitting at the bus stop at 23 AV E and E Aloha ST, MK was standing a short distance away. A male approached them and walked past the bus stop. The male then turned around at the corner and walked back.

The male's pants were open and his penis was exposed. KM stated that the man was not wearing underwear. KN stated that the male's penis was at KN and KM's eye level. KN stated the male "grabbed his penis and began shaking it at their face." KN and KM were seated and the bus stop and felt that they could not leave the bus stop, as the male was standing in their way.

MK could see the man from where she was standing and saw him expose his penis.

The man then ran off and got into his nearby vehicle. KN described the vehicle as a tan/beige 4 door car, perhaps maybe a Toyota Camry.

KN, KM, and MK gave very similar suspect descriptions. White male, about 5'10 or 5'11, thin build with a thin face. Dark brown or black goatee with a narrow face. MK described his complexion as pale. All three victims stated that he had a black hood that was pulled up over his head.

On 10.17.2011, Det. Smith presented a photo montage to KN. KN selected the photo of Jesse K. Drugge as being the male who exposed his penis to her.

On 10.17.2011, Det. Smith presented a photo montage to KM. KM selected the photo of Jesse K. Drugge as being the male who exposed his penis to her.

KN and KM were presented the photo montages separately.

<u>SPD 2011-325207</u>: This incident occurred on 10.3.2011, at about 1635 HRS, at Lakeside HS, 14050 1 AV NE Seattle, WA 98125.

The victim in this incident is FB (birthday 06.30.1996). The witnesses in this incident are KM (birthday 05.27.1996), KK (birthday 03.03.1996), and JA (birthday 01.23.1978).

FB, KM, and KK were practicing at the Lakeside Upper School Soccer Fields, located on the West side of 1 AV NE, just South of NE 145 ST. They all noticed a strange man looming around the soccer field. They described the male as a white male, about 5'10, and thin. They described his face as very thin, and that he appeared "malnourished" because his cheeks were sunken in. FB stated that she remembered his nose being "distinct." They stated that the male had unshaven facial hair. KM stated that the male's eyes were blue, or at least appeared to be light.

FB, KM, and KK stated that the male was wearing a black jacket/sweatshirt, with the hood up.

All of them noticed the male watching them play soccer. However, FB, was the only person who looked over and saw that he was exposing his penis.

FB began screaming at the man, "What are you doing? Pervert!!!!" The male ran across 1 AV NE and got into his vehicle. He drove N/B in the S/B lanes of 1 AV NE to go around traffic stopped at the light, and then ran the red light on NE 145 ST.

They described his vehicle as being an older, gold, 4 Door sedan.

JA (a school staff member) stated that she'd seen the man lurking around the school property just before the incident at the Soccer Field. JA saw the man walking behind the school and actually walk onto school campus. JA looked at the male, and the two made eye contact for a few

minutes. When JA lifted her cell phone to call 911, the male ran away. JA provided a description very similar those provided by FB, LM, and KK.

On 10.17.2011, I presented a photo montage to JA. JA selected the photo of Jesse K. Drugge as being the male who was wandering around Lakeside School premises just prior to the exposure incident on the soccer field.

On 10.17.2011, I presented a photo montage to FB. FB selected the photo of Jesse K. Drugge as being the male who exposed his penis to her.

JA and FB were presented the photo montage separately.

I am currently investigating two additional indecent exposure cases, SPD 2011-335448 and SPD 2011-228389, in which the suspect descriptions and MO strongly match those listed in this Certification of Probable Cause.

DRUGGE is clearly a danger to the community. DRUGGE has been identified as the person who exposed his penis to juveniles in five separate incidents within the city of Seattle. All of these incidents occurred over a short period of time. All of these incidents occurred at or near schools and/or playgrounds.

DRUGGE's behavior is especially concerning, as he is not just exposing his penis and hoping that people are able to see. He is getting extremely close to the juvenile victims, engaging them, ensuring that they make eye contact, and making sure that they notice he has his penis out. DRUGGE followed one juvenile home and then paced outside of his house. Furthermore, on 10.2.2011 DRUGGE had physical contact with one victim when he ejaculated on her.

DRUGGE is not currently employed. DRUGGE does not own a home. DRUGGE is not married and does not have any ties to the local community.

### PROSECUTING ATTORNEY CASE SUMMARY AND REQUEST FOR BAIL AND/OR CONDITIONS OF RELEASE

The State incorporates by reference the Certification for Determination of Probable Cause written by Detective Lauren Givens in Seattle Police Department Incident Number 11-324235 and signed on October 19, 2011.

### REQUEST FOR BAIL

The State requests bail in the amount of \$250,000, pursuant to CrR 2.2 (b) (2) (i), (ii), (iii), and (iv). The amount set at first appearance was \$100,000.

The defendant is charged with Child Molestation 2° for ejaculating on the jacket of a girl, age 11, who was a stranger he targeted in the park. The defendant is a significant danger to the community, targeting minors in places where they congregate -- school, parks, and bus stops. His crimes are frequent -- three on one day are charged here -- and escalating in seriousness.

The defendant has a prior conviction for Indecent Exposure (2005), also involving a minor. That conviction elevates each of the five counts of Indecent Exposure charged here to felony offenses.

The State also requests a no contact order be issued for the protection of JH, IS, AN, MR, KW, MS, KN, KM, MK, FB, and minors.
