14 INCIDENT DESCRIPTION / NARRATIVE:

{On 09-22-11 at approximately 2256 hours, Suspects Johannes, <sup>s/2</sup> [REDACTED], <sup>s/3</sup> [REDACTED], <sup>s/4</sup> [REDACTED], <sup>s/5</sup> [REDACTED], and <sup>s/6</sup> [REDACTED] were found by Wintess, Security Officer w/ [REDACTED], (who is employed by "[REDACTED]" to safeguard the building), hiding inside a vacant building located at 1250 Denny Way. The building was formerly used as a Greyhound Bus maintenance facility and is now owned by Seattle City Light. The building and grounds are surrounded by a fence and all the doors were secured either by locks and chains, or were boarded over to prevent unauthorized access.

Security Officers noticed a door open, (no damage was done to the door), on the south side of the building and found the six suspects had illegally entered the fenced yard, and then entered the building without permission and had illegally remained within the building in violation of SMC 12A.08.040 - Criminal Trespass.

w/ [REDACTED] found the suspects hiding in the dark garage area. The suspects initially complied with orders from w/ [REDACTED] to sit on the floor and wait for police to arrive. Without warning Johannes jumped up and took a fighting stance with both hands in fists, arms flexed forward and leaning toward w/ [REDACTED]. Johannes was reportedly very aggressive and began yelling, "Fuck You" and "You can't make us stay here". Johannes leaned into w/ [REDACTED] with his hands still balled in fists drawn back as if about to assault him in violation of SMC 12A.06.010 - Harassment. Johannes continued yelling, "What are you gonna do about it, fuck you" and "You can't make me". Johannes continued to make threats and told w/ [REDACTED] that he was a DOC escapee for felony assault.

I attempted to identify all of the suspects, and asked Johannes directly for his identification. Johannes lied saying he didn't have any while he concealed his wallet under his shirt at his right hip. Johannes verbally gave me the false name of "Young, Tito L." with a DOB of [REDACTED]. Johannes knowingly gave false information during an investigation in violation of SMC 12A.16.040. Young is a known AKA of Johannes', who was found to have an outstanding, No Bail escape warrant for Assault 3 (Warrant #344640) Johannes was placed under arrest for Criminal Trespass, Harassment, False Reporting and for the Warrant. Johannes was read his Miranda Rights by Officer Meyers #5452. Johannes was transported to the West Precinct and was subsequently booked into KCJ.

Suspect <sup>s/2</sup> [redacted] verbally gave me the false name of "Willard, Jessica M." with a DOB of [redacted]-[redacted]-1[redacted]. When questioned further, <sup>s/2</sup> [redacted] gave her true name and said she had lied because she was a runaway. <sup>s/2</sup> [redacted] was found to have an outstanding No Bail, Juvenile Court Warrant (#977030003 - Dependency) Seattle. <sup>s/2</sup> [redacted] was placed under arrest for Criminal Trespass and for the Juvenile Warrant. <sup>s/2</sup> [redacted] was read her Miranda Rights, including the Juvenile portion, by Officer Scott. <sup>s/2</sup> [redacted] was transported to the West Precinct and was subsequently booked into YSC.

Suspect <sup>s/5</sup> [redacted] said she is three months pregnant with Johannes' baby and began crying when he was arrested. <sup>s/5</sup> [redacted] began holding her stomach and was screaming it hurt. <sup>s/5</sup> [redacted] was treated at the scene and transported to HMC by SFD (A2). Request charges be filed against <sup>s/5</sup> [redacted] for Criminal Trespass.

Suspects <sup>s/3</sup> [redacted], <sup>s/4</sup> [redacted], and <sup>s/6</sup> [redacted] were cooperative and were I&R'd at the scene. Request a charge of Criminal Trespass be filed against <sup>s/3</sup> [redacted], <sup>s/4</sup> [redacted] and <sup>s/6</sup> [redacted].

The entire incident, arrests and the I&R of suspects was screened by Sgt Edwards. >}
