One roll up loading dock door in the vacant property was found to be unlocked. I secured it by locking it from the inside. Another person door near where the holes had been made (not the one that had been forced to gain entry) was unsecured. The suspects had unlocked the deadbolt from the inside. A second latch would normally lock itself when the door is shut. Once the suspects had opened the door from the inside, they shoved a screw into the latch to prevent the bolt from extending and securing the door. The vacant property is scheduled for demolition in the next few months.

I noted that there were several shoe tread prints near the holes in the wall. The person leaving the prints had walked through the dust and debris from the broken cinderblock wall and left the prints behind. I photographed and fingerprinted the scene. I was unable to find any fingerprints.

is concerned that this incident is related to a recent burglary at outside Seattle. believes that the suspect's entered by prying a door in that incident, but was not sure.
