COMPLAINT FOR DAMAGES

COME NOW Plaintiffs and hereby allege as follows:

This is an action under 42 U.S.C. § 1983 and state law for damages arising from the July 22, 2011 warrantless entry and use of excessive force to break up a party at 2990 S. Dakota St., Seattle, Washington. After responding to a noise complaint, Defendant officers entered into the backyard of the house without a warrant over the protests of the tenant and guests. They refused to leave when asked and remained for several minutes, despite no exigency, until withdrawing to the front yard where the tenant had gone to talk to the officers. When the officers arrested the tenant without probable cause, the guests protested in the side yard behind a closed fence. The protest prompted at least one officer to re-enter the yard and charge the crowd. Other officers

1 followed and hit several of the people present, including the Plaintiffs, with batons, flashlights,
2 fists, and a shovel.

3 To cover themselves, officers arrested several people without legal cause, including
4 Plaintiffs Matthew Adams, Glenn Crespo, and Katie Gan. Officers also submitted false and
5 misleading reports to support unfounded criminal charges, caused Plaintiffs Adams, Crespo, and
6 Gan to be jailed for three days, and recommended that they be prosecuted for assaulting an
7 officer and other crimes.
8

9 On July 25, 2011, Plaintiffs Adams, Crespo, and Gan were released from custody.
10 Despite the officers' reports and recommendations, the King County Prosecuting Attorney's
11 Office declined to file any charges based on this incident.
12

13 I. PARTIES

14 1.1 Plaintiffs.

15 1.1.1 Matthew Adams was, at all relevant times, a resident of King County,
16 Washington and the Western District of Washington.

17 1.1.2 Glenn Crespo was, at all relevant times, a resident of Pierce County,
18 Washington and the Western District of Washington.

19 1.1.3 Connor Day was, at all relevant times, a resident of Thurston County,
20 Washington and the Western District of Washington.

21 1.1.4 Katie Gan was, at all relevant times, a resident of Pierce County,
22 Washington and the Western District of Washington.

23 1.1.5 Soledad Picon was, at all relevant times, a resident of King County,
24 Washington and the Western District of Washington.

1 1.2 **Defendants.**

2 1.2.1 Defendant David Bauer is a law enforcement officer who, at times
3 relevant to this Complaint, worked for the Seattle Police Department.

4 1.2.2 Defendant Jacob Briskey is a law enforcement officer who, at times
5 relevant to this Complaint, worked for the Seattle Police Department.

6 1.2.3 Defendant Lindsay Brown is a law enforcement officer who, at times
7 relevant to this Complaint, worked for the Seattle Police Department.

8 1.2.4 Defendant Bruce Creamer is a law enforcement officer who, at times
9 relevant to this Complaint, worked for the Seattle Police Department.

10 1.2.5 Defendant Lloyd Harris is a law enforcement officer who, at times
11 relevant to this Complaint, worked for the Seattle Police Department.

12 1.2.6 Defendant Stephen Knapp is a law enforcement officer who, at times
13 relevant to this Complaint, worked for the Seattle Police Department.

14 1.2.7 Defendant Stephanie Marks is a law enforcement officer who, at times
15 relevant to this Complaint, worked for the Seattle Police Department.

16 1.2.8 Defendant Nathan Patterson is a law enforcement officer who, at times
17 relevant to this Complaint, worked for the Seattle Police Department.

18 1.2.9 Defendant Adam Thorp is a law enforcement officer who, at times
19 relevant to this Complaint, worked for the Seattle Police Department.

20 1.2.10 Defendant City of Seattle is a municipal corporation located in the
21 Western District of Washington. The Seattle Police Department is an agency of the City of
22 Seattle.

1 3.5 Plaintiff Crespo told the officers that Andrew Stoffel, who rented the property and
2 lived there, would speak with the officers in front of the house. The officers then left the
3 backyard and were joined in front by other SPD officers.

4 3.6 According to the police report, the officers met with Mr. Stoffel and told him to
5 quiet his party down. Mr. Stoffel told the officers the guests would be quiet when the officers
6 left. Plaintiffs and other guests had moved to the edge of the side yard and from behind the gate
7 watched the interactions between Mr. Stoffel and the officers.
8

9 3.7 Sgt. Creamer ordered that Mr. Stoffel be arrested for obstruction and SPD officers
10 grabbed him. Mr. Stoffel had been talking to Officer Marks and not resisting.

11 3.8 When the group of guests behind the gate saw this they yelled out, “Hey! what are
12 you doing?!” Officer David Bauer or another officer said, “Come on motherfuckers, let’s do
13 this.” Officer Bauer, Officer Nathan Patterson, Officer Jacob Briskey, Officer Lloyd Harris,
14 Officer Stephen Knapp, and other officers charged through the gate into the backyard and began
15 hitting the guests.
16

17 3.9 As the officers moved in, the guests backed into the yard. An officer, who
18 Plaintiffs are informed and believe was Defendant Bauer, picked up a shovel and started using it
19 to push people away from the gate and into the yard.
20

21 3.10 Plaintiff Connor Day was near the side of the house as the officers came through.
22 Defendant Bauer or other officer struck Mr. Day in the head with the shovel and split open his
23 scalp causing him to crumple to the ground. Two guests were nearby when Mr. Day was struck
24 and injured. An officer kicked the male guest huddled against the house and punched the woman
25 guest in the face.
26
27

1 3.11 Plaintiff Soledad Picon fell to the ground with the push of the officers. As she
2 struggled to get to her feet, she felt a painful blow to her back from a blunt object. From the
3 ground, Ms. Picon looked over her shoulder and saw Defendant Bauer or other officer holding
4 the shovel with the blade pointed up. He hit her again in the back as she tried to get away from
5 him.
6

7 3.12 Plaintiff Katie Gan was on the ground, near Ms. Picon. After getting hit herself,
8 Ms. Picon saw the officer hit Ms. Gan in the head with the shovel. Officer Marks, Officer Bauer,
9 Officer Lindsay Brown, and other officers falsely claimed that Ms. Gan had assaulted an officer
10 and arrested her.

11 3.13 Plaintiff Glenn Crespo was near Ms. Gan and Ms. Picon. He cried out why they
12 were hitting Ms. Gan, his girlfriend. The officers told him to shut up and get down. Mr. Crespo
13 complied and got on the ground. Officers arrested Mr. Crespo and handcuffed him. On
14 information and belief, Sgt. Creamer, Officer Patterson, and/or other officer punched Mr. Crespo
15 while he was still on the ground and after he was handcuffed. As Defendant officers removed
16 Mr. Crespo from the backyard, other Defendant officers struck him in the torso and head with
17 flashlights, batons, knees, or fists. The officers falsely claimed that Mr. Crespo had assaulted an
18 officer.
19

20 3.14 Plaintiff Matthew Adams was cornered next to some stairs that led to a back door
21 to the house. On information and belief, Officer Briskey and/or other officer tased Mr. Adams,
22 used a baton or other instrument on him, and stomped on his leg. Officer Briskey then arrested
23 Mr. Adams, based on the false claim that Mr. Adams had assaulted an officer.
24

25 3.15 Friends took Mr. Day to Harborview Medical Center for emergency medical
26 attention. The officer's shovel blow split Mr. Day's scalp open. Emergency room physicians
27

1 diagnosed Mr. Day with “acute headache trauma from a blunt object with resultant moderately
2 large right parietal scalp laceration [and] underlying hematoma.” Mr. Day received several
3 staples in his scalp to dress the laceration.

4 3.16 Mr. Adams, Mr. Crespo, Ms. Gan, and others arrested were taken to the SPD
5 South Precinct for booking. As they arrived, a supervising officer told another officer to make
6 sure Ms. Gan was charged with assault. When Mr. Crespo arrived, officers intimidated him and
7 said that he could look forward to being raped at the King County Jail.

8 3.17 Ms. Gan, dazed from the shovel blow, asked to go to Harborview Medical Center
9 where, according to hospital records, she had “pain back of head” because “she was hit w/blunt
10 instrument.” She was diagnosed with “occipital hematoma.”

11 3.18 Mr. Crespo also went to Harborview Medical Center in police custody that night,
12 for treatment of injuries he received in the police beating. Harborview medical staff diagnosed
13 him with “abrasions over sternum and left flank with small areas of bruising.”

14 3.19 Defendant officers filed knowingly and/or recklessly false and misleading reports
15 to support unfounded charges of assault on a police officer and riot. The officers’ fabrications
16 and/or mischaracterizations in these reports were designed to cover the officers’ unlawful
17 actions.

18 3.20 Mr. Adams, Mr. Crespo, and Ms. Gan were detained at King County Jail and
19 released three days later, on Monday, July 25, 2011. Sgt. Creamer, Sgt. Waltz [first name
20 unknown], and Lt. Towne [first name unknown] reviewed the officer reports and, on information
21 and belief, approved a “rush filing” to recommend to the King County Prosecuting Attorney’s
22 Office that assault and riot charges be filed. On July 27, 2011, the deputy King County
23

1 prosecutor declined the rush filing and all arrestees from the incident remained released on
2 personal recognizance.

3 3.21 Plaintiff Matthew Adams went to the hospital several days later after his leg pain
4 worsened. He was x-rayed and, according to hospital records, was diagnosed with “a distal third
5 fibular shaft transverse fracture of his fibula [in] . . . essentially what could be conceptualized as
6 a nightstick injury to that area due to beating with batons by police officers.”
7

8 3.22 The Seattle City Attorney’s office filed “obstruction” charges against Mr. Stoffel.
9 In August 2012, on the eve of trial, the City prosecutor dismissed the charge citing “evidence
10 problems.”

11 3.23 In the months following the July 22, 2011 incident, Plaintiffs provided
12 information to the deputy King County Prosecutor who was investigating the assault charges
13 recommended by SPD. The King County Prosecuting Attorney’s Office declined to file any
14 charges arising out of this incident.
15

16 3.24 The actions of the Defendants described above were taken pursuant to the
17 policies, customs and usages of the Seattle Police Department and under color of the laws of the
18 State of Washington. As determined by the U.S. Department of Justice on December 16, 2011,
19 SPD officers had during this time period a pattern and practice of Fourth Amendment abuses
20 including, among other things, (1) using excessive force when dealing with minor offenses, (2)
21 allowing multiple officers to use force on single individuals, (3) resorting too quickly to impact
22 weapons (such as batons and flashlights), (4) using force against persons who have already
23 surrendered, (5) using force against persons who “talk back,” and (6) failing to take action at the
24 first line supervisory level to stop subordinate officers’ use of excessive force.
25

1 4.2.2 Officer Briskey is liable, at minimum, for the warrantless entry; for using
2 excessive force including unreasonably tasing Plaintiff Adams, using a baton or other instrument
3 on him, and/or stomping on his leg; and for arresting Plaintiff Adams based on the false claim
4 that Plaintiff Adams had assaulted an officer to support an arrest and malicious prosecution.
5

6 4.2.3 Defendant Brown is liable, at minimum, for the warrantless entry; and for
7 using excessive force against Plaintiffs Crespo, Gan, and/or Picon alone or in conjunction with
8 other officers; and for falsely reporting that Plaintiff Gan had assaulted an officer and arresting
9 her without cause.

10 4.2.4 Sgt. Creamer is liable, at minimum, for the warrantless entry; for using
11 excessive force against Plaintiff Crespo, Gan, and/or Picon; for falsely reporting Plaintiff Crespo
12 had assaulted an officer to support a false arrest and malicious prosecution; and for approving a
13 rush filing to charge Plaintiffs Adams, Crespo, and Gan without legal cause.
14

15 4.2.5 Officer Harris is liable, at minimum, for the warrantless entry; and for
16 using excessive force against Plaintiffs Crespo, Gan, and/or Picon alone or in conjunction with
17 other officers.

18 4.2.6 Officer Knapp is liable, at minimum, for the warrantless entry; and for
19 using excessive force against Plaintiffs Crespo, and/or Picon alone or in conjunction with other
20 officers.
21

22 4.2.7 Officer Marks is liable, at minimum, for the warrantless entry; for using
23 excessive force against Plaintiffs Crespo, and/or Picon alone or in conjunction with other
24 officers; and for falsely claiming that Plaintiff Gan had assaulted an officer to support a false
25 arrest and malicious prosecution.
