HEIDI WILLS CAMPAIGN FINANCE VIOLATIONS

Complaint to the Seattle Ethics and Elections Commission

CHARGE 1: HEIDI WILLS VIOLATED CAMPAIGN CONTRIBUTION LIMITS Pursuant to SMC 2.04.370:

No person shall contribute more than \$500 to any candidate for Mayor, member of the City Council, or City Attorney of the city, in any election cycle.

Heidi Wills received more than \$5,000 through an in-kind contribution but declared its value as just \$1,000.

James Riggle and the Hotel Ballard, owned by James Riggle, hosted a Heidi Wills fundraiser for on October 8, 2019¹ in the hotel's luxury rooftop pavilion space. On 10/8/19, the day of the fundraiser, Wills reported collecting more than \$11,000 from more than 50 contributors.² One attendee reported 70 people at the fundraiser.³

According to Hotel Ballard's website:4

The Olympic Rooftop Pavilion provides 1,370 square feet of event space featuring views of old downtown Ballard, beautiful mountains, and waterways. The rooftop pavilion features state of the art audio visual equipment, vaulted ceilings with a skylight, and west facing NanaWalls. Outside of the pavilion, the patio space features a large fire place, chairs, and a standing bar making the Olympic Rooftop Pavilion and patio area an idea space for any event.

Features:

- Exclusive catering through Stoneburner
- Two antique chandeliers
- Outdoor fireplace and chairs
- Sweeping views of old downtown Ballard, waterways, and mountains
- Occupancy: up to 100 guests for dinner

Heidi Wills falsely declared the event space's true market value, in clear violation of Seattle's law prohibiting city council candidates from accepting contributions greater than \$500. Hotel

Ballard's restaurant, Stoneburner, normally charges a \$1,000 event set up fee plus \$100 for linens, not including food, drink and alcohol.⁵

Heidi Wills also falsely declared the true market value of catering for 70 at just \$500. Hotel Ballard's restaurant normally charges a \$4,000 minimum for catering. According to an email from the Stoneburner Director of Sales and Catering:

Room rental includes set-up, teardown, staff, **standard linens (\$100 fee**), tables and chairs for 100 guests and votive candles. The **food & beverage minimum for the Pavilion is \$4,000** and a rental fee of \$1,000. Tax and service charge are additional.⁶

CHARGE 2: HEIDI WILLS VIOLATED LAWS PROHIBITING CONCEALMENT OF SOURCES Pursuant to SMC 2.04.290:

No contribution shall be made and no expenditure shall be incurred, directly or indirectly, in a fictitious name, anonymously, or by one person through an agent, relative, or other person in such a manner as to conceal the identity of the source of the contribution or in any other manner so as to effect concealment.

To further conceal the true monetary value of the fundraiser and get around contribution limits, Heidi Wills appears to have falsely reported the in-kind contribution as split between two entities.

While Stoneburner normally handles all event fees and catering in the pavilion,⁷ Heidi Wills declared the contribution as split between lessor Hotel Ballard (owned by James Riggle) and lessee Stoneburner (owned by James Lechner's Bastille2 LLC).

It is important to note that Hotel Ballard owner James Riggle maxed out his personal contribution to Heidi Wills as an individual on 9/30/19 and was listed as an official host of the 10/8/19 fundraiser. The general manager at one of Riggle's other properties, the Olympic Athletic Club, also contributed⁸ the maximum \$500. The Olympic Athletic Club recently emailed its gym members a statement of support for Heidi Wills on 10/17/19.9
