On 02-07-11 at approximately 2139 hours staff from the [REDACTED] called 911 to report an assault that had happened inside the facility. Officer K. Jones and I responded along with SFD A-5.

The victim, [REDACTED], was in the lobby holding an ice bag to his right eye, I could see blood and swelling around the eye. I asked [REDACTED] what had happened and he pointed to witness [REDACTED]. I asked [REDACTED] who is a [REDACTED], what happened. W/[REDACTED] told me he did not see the fight but it had happened downstairs where they shelter men overnight. W/[REDACTED] said the fight was over a complaint [REDACTED] had made with the staff about the suspect - [REDACTED] said V/[REDACTED] spoke to the staff about inconsistent enforcement of rules by [REDACTED]. [REDACTED] said the staff discussed the issue amongst themselves to resolve the complaint. Somehow S/[REDACTED] heard about the complaint and became upset with [REDACTED] W/[REDACTED] said S/[REDACTED] was considered a helper at [REDACTED]

Officer Jones spoke to witness [REDACTED], who saw the attack. [REDACTED] said he was in the downstairs restroom when he saw S/[REDACTED] grab V/[REDACTED] and put him in a headlock. S/[REDACTED] proceeded to punch V/[REDACTED] multiple times in the face and knocked him to the ground and kicked him in the head. W/[REDACTED] grabbed S/[REDACTED] and pulled him off of V/[REDACTED] to stop the assault. According to W/[REDACTED] V/[REDACTED] lost consciousness.

I spoke briefly to V/[REDACTED] while he was being treated by SFD. V/[REDACTED] said he did not file a complaint against S/[REDACTED] but just wanted to mention it to staff. V/[REDACTED] said he was walking to the bathroom when he was jumped by S/[REDACTED] V/[REDACTED] said he did not lose consciousness.

S/[REDACTED] fled [REDACTED] prior to our arrival.

V/[REDACTED] was transported to HMC via AMR for additional evaluation and treatment.
