On 04-29-2011 at 1852 hours, W [REDACTED] called 911 to report V/[REDACTED] and S [REDACTED] were involved in a physical altercation near 16 AV S and S Lucile St. W [REDACTED] stated one of the parties was striking the other with the stick, and a "fast-backup" was requested. Officers arrived on-scene and met with W/[REDACTED]

W [REDACTED] stated both parties, and multiple witnesses that were involved in the disturbance had run inside 53 [REDACTED] S Lucile St. Officers were unsure if anyone was still being harmed inside the residence, and decided to make entry to ensure the safety of all the parties involved.

Officers entered the home and located W/[REDACTED] V [REDACTED] and S/[REDACTED]. The Suspect was found hiding in the garage of the residence while the Victim was found in the master bedroom. All parties were brought outside of the home to allow for a thorough investigation.

W/[REDACTED] had another Witness with him that took video footage of the assault. W/[REDACTED] showed Officers clear footage of S [REDACTED] taking a 1x4 stick, and striking the head of V [REDACTED]. In the video, the Victim falls to the ground, apparently knocked unconscious. V [REDACTED] then gets up, grabs the stick and starts to swing at the Suspect. W [REDACTED] and W [REDACTED] were in the middle of the disturbance, trying to stop both parties.

According to the Witnesses that were involved in the disturbance, S [REDACTED] and V/[REDACTED] were drinking together and arguing. S [REDACTED] became mad at V/[REDACTED] in regards to his sister, W [REDACTED]. W [REDACTED] is also the girlfriend of V [REDACTED]. The disturbance spilled over onto the sidewalk, with S [REDACTED] striking V/[REDACTED].

All Witnesses were unclear as to exactly why the two were fighting, only that they refused to give written statements to Officers at the scene. S [REDACTED] was placed under arrest for Investigation of Assault with a weapon due to the footage taken. S [REDACTED] was transported to the South Pct.

While at the South Pct., S [REDACTED] stated he struck V/[REDACTED] with the 1x4 because he found out V [REDACTED] had been beating his Sister, W/[REDACTED]. At the scene, multiple Officers tried to gain the exact information as to what took place between the two males, but W [REDACTED] would not give any information. V [REDACTED] refused to provide a written statement at the scene.
