On 04.29.2011 I was working marked patrol as 3U31 in full uniform. At approximately 0020 hours I was dispatched to the area of NE 47█/ 11 AV NE reference a possible assault with a knife. Information provided to the call taker indicated that the suspect was a black male in his 20's and the victim was a white male also in his 20's with no shirt.

I arrived with another officer and initially did not locate any victim, suspect or any signs of a disturbance. We made an area check and did not find anyone, so I went to contact the complainant. I located the complainant, █ who stated that he was a ways away but believed he observed the black male on top of the white male and the two were struggling. He stated that the two then got up and walked away. He thought he saw the white male bleeding from his back.

As I was talking to C/█ he pointed out a white male walking with a black male southbound from where I had just made an area check. I asked C/█ to stand by while I contacted the two with other officers. Victim █ and subject █ but had conflicting stories, neither of which involved them fighting each other. V█ stated that he was walking with S█ when an unknown transient male came up and stabbed him in the back. V/█ stated he did not see the male and therefore could not provide any suspect description or direction of travel.

S█ stated that he and V/█ were walking and two males in ski masks came up and stole his phone. He could not tell me how he received the laceration to his hand, or how V█ got injured. His description of the two male suspects were unknown race males in their 20's average height no clothing description or direction of travel. S/█ stated that these males took his phone, however he could not describe the model of his phone to me except that it was blue and cost█

SFD responded to treat both males for their lacerations. They suggested that V█ be further treated at HMC. V█ agreed and was transported to HMC via AMR. S█ requested to go with V█ in the AMR. Neither V/█ nor the AMR crew objected so S/█ rode with V/█ to HMC. A/Sgt. Kibbee responded to the scene and screened the incident. He also took photos of the males' injuries which were submitted into evidence.

The immediate area was checked however no knives were located. Additionally, neither of the males had knives on their persons.
